Foreword to the 1985 Revised Edition of Acts

Since the publication of the 1970 Revised Edition of the Laws of the Republic of Singapore, many new laws have been enacted by Parliament and extensive changes and additions to existing laws have also been made because of Singapore's social, political and economic developments. As a result, reference to the statute law on various subjects has become difficult.

A Law Revision Commission consisting of six Law Revision Commissioners was therefore appointed in 1982 to prepare and publish a revised edition of Acts and a revised edition of subsidiary legislation and to make an annual revision thereof. The revised edition of Acts has now been completed. The revised edition of subsidiary legislation is in progress and is expected to be published within the next few years.

This Edition differs from the 1970 and earlier revisions in 3 respects. Firstly, for the first time the production of an edition is made in "loose-booklet" form. Secondly, the Acts are placed in alphabetical order and a new Act will be inserted in its appropriate alphabetical order among the existing Acts and be allotted a Chapter number. Thirdly, the Acts may be revised at regular intervals by the issue, in the form of a separate booklet, of a revised edition of any Act which has been amended during the preceding year, with instructions for the up-dating of the laws by the insertion of the new booklets and the removal of spent ones. In this way, the laws of Singapore can be constantly kept up to date.

This Edition will not only meet the needs and expectations of the legal profession, public service, business community and the general public, it will also be of value to all those who participate in the administration of the law.

Preface to the 1985 Revised Edition of Acts

This Revised Edition of Acts has been prepared by the Law Revision Commissioners under the authority of the Revised Edition of the Laws Act (Chapter 275) and includes the Acts in force on 31st December 1986. The Revised Edition of Acts will in all courts and for all purposes be the sole and only proper Statute Book of the Republic of Singapore in respect of Acts contained in it.

Scheme of the Revised Edition. The Edition consists of —

- (a) the Republic of Singapore Independence Act, the Independence of Singapore Agreement and the Constitution of the Republic of Singapore — which, as the fundamental law of the land, are published first among the substantive laws of the Edition, and are not allotted Chapter numbers;
- (b) the statutes of general and particular application still in force in Singapore; and
- (c) the accessory items specified in the Table of Contents.

This Edition does not, however, include English statute law applicable to Singapore by virtue of the Charter of Justice 1826 nor other Imperial Legislation which have current application to Singapore.

Alterations. The alterations incorporated in the Acts are those made by legislation, those made by means of subsidiary legislation and textual alterations made by the Commissioners in preparing the Edition. Alterations the Commissioners may make are described in section 4 of the Revised Edition of the Laws Act. Further alterations considered desirable by the Commissioners and submitted to Parliament under section 6 of that Act were given effect by the Statute Law Revision Acts 1986 and 1987 and these are incorporated in the present Edition.

Arrangement. Acts are arranged according to their alphabetical order, and are given chapter numbers in the order in which they appear. The year of enactment is omitted from the short title of each Act. The date of commencement of each Act is given after the long title, and words in an Act fixing a date for its commencement are omitted if they have taken effect. Enacting words are usually omitted; repealing enactments and enactments that have been repealed either expressly or by necessary implication are omitted unless they have some residual operation; and amending and spent enactments are omitted. Where this leaves a gap in the numbering of sections or other divisions of an Act, or where there are numbers with suffixes, e.g. 1A, 1B, etc., or where numbered provisions from another Act are incorporated, they are usually renumbered. For reference purposes, where a section is renumbered the old number is given after a square bracket at the end of the section.

Marginal notes. Where a section or subsection incorporates the effect of an amendment or consequential modification made since the previous publication of an Act, an abbreviated note in the margin gives the number and year of the amending Act. The effects of general modifications and of textual alterations made by the Commissioners are numerous and few of them are annotated. Usually a

reference in the text to another Act in this volume is accompanied by a marginal note of its chapter number. Abbreviations used are:

Introduction to the Loose-leaf Revised Editions

In July 1994, the Revised Edition of the Laws Act (Chapter 275) was amended to empower the Law Revision Commissioners to prepare and publish the revised editions of Acts and subsidiary legislation in loose-leaf form.

2. The loose-leaf system allows for an Act to be more quickly, easily, economically and conveniently updated than the loose-booklet system which has been in use since the 1985 Revised Edition of Acts was first published.

3. Under the loose-leaf system, whenever an Act has been amended, all that a user will have to do is to purchase the supplement of new pages and replace the spent pages therewith. There is no need for the replacement of the entire Act itself with a new revised edition thereof, as is the case with the loose-booklet system.

4. As supplements of new pages may be more quickly issued than a new revised edition of an entire Act, users will not have to wait very long before they can have an up-to-date version of any Act which has undergone amendment.

5. The loose-booklet system will be phased out and replaced by the loose-leaf system in the following manner:

- (a) the revised edition of every new Act or any Act which has undergone amendment will henceforth be published in loose-leaf form; and
- (b) existing Acts which have not undergone any amendment will be revised in loose-leaf form sequentially according to their Chapter numbers, and in batches at convenient intervals.

Thereafter, whenever any of such Acts in loose-leaf form is amended, a supplement of new pages will be issued together with the necessary filing instructions.

6. The Civil List and Pension Act (Chapter 44), the Insurance Act (Chapter 142) and the Road Traffic Act (Chapter 276) were revised in loose-leaf form on 15th July 1994. More Acts will be revised in loose-leaf form in 1995.

7. I am confident that every user will find the loose-leaf editions to be more efficient and convenient than the loose-booklet system.
